If my Artwork is selected as the winning entry, effective immediately upon such selection, I hereby irrevocably assign and transfer to Green Shirt Day all right, title, and interest in and to the Artwork, including all copyright and other intellectual property rights, worldwide, for the full term of such rights (including any renewals, extensions, and revivals), free and clear of all claims, liens, and encumbrances. I agree to sign and deliver any further documents and do any further acts reasonably requested to evidence or give effect to this assignment. To the extent permitted by law, I waive any moral rights I may have in the Artwork in favour of Green Shirt Day, and anyone authorized by them. The \$1,000.00 prize is agreed to be good and sufficient consideration for this assignment.

I hereby release and forever discharge Green Shirt Day, and each of its affiliates, directors, officers, agents, employees, volunteers, representatives, and guests, from any and all claims, demands, damages, liabilities, costs, and expenses of any kind arising from or related to any use of the Artwork and/or the entrant's name as described above, to the fullest extent permitted by law.
